SPP and Placement Raises \$1.6 Million

- **Funds will be allocated to exploration at Fraser Range, Southern Cross and Forrestania, due diligence on potential acquisitions and working capital**

Hannans Ltd (ASX:HNR) (**Hannans** or the **Company**) is pleased to announce the recently completed SPP and Placement raised \$1.605 million at an issue price of 0.44 cents per share.¹

Hannans would like to acknowledge the large number of Hannans shareholders that participated in the capital raising and placement, in particular the Company's largest shareholder Neometals Ltd who subscribed for \$365,000 in the placement.

Funds from the capital raising will principally be allocated towards making a major discovery of:

- nickel-copper at Fraser Range;
- nickel and gold at Southern Cross; and or
- nickel at Forrestania.
